I have decided to donate blood stem cells/lymphocytes for a patient needing transplantation.

The Ordinance on the Transplantation of Human Organs, Tissues and Cells requires all bone marrow and peripheral blood stem cell donors in Switzerland to receive regular follow-up for 10 years. According to Swiss Blood Stem Cells/Swiss Transfusion Sko regulations, this also applies to lymphocyte donation (DLI).

Various cell harvest and follow-up data relating to all dem ed to be collected in pseudonymised form (name replaced by a multidigit monation of letters or numbers) for later evaluation. These data may be accessed and reviewed by the Federal Office of Public Health. All persons authorised to do so are bound by the professional duty of confidentiality.

In addition, some of these data are shared in a international registry and entered into a database: the transplant registry of the European Group for Blood and Marrow Transplantation (EBMT). The data collected in the E^rM^T database are accessible only to medical professionals and registry employees, all of whom a seb and by the professional duty of confidentiality. The data include donor number, gen ler, law of birth, donor health status, and details of the cell harvest and any adverse real tion

Information on the transacion of personal data: starting from the sixth month after the donation, Swiss Block Ster Cells (SBSC), a department of Swiss Transfusion SRC, follows up with donors via que tir poire and/or telephone. In order to send me the questionnaire or contact me by the je, SBSC needs personal data relating to you: specifically, your surname, given name, it is g address, telephone number and e-mail address.
